

**JUPITER TEQUESTA ATHLETIC ASSOCIATION, INC.
WAIVER**

IN CONSIDERATION of _____ (child's name) (hereinafter "Participant") being given the opportunity to participate in any Jupiter Tequesta Athletic Association, Inc. ("JTAA") activities, including, but not limited to travel sport activities provided by the JTAA or other organizations (hereinafter "Activity"), until the end of the Participant's registration, I, for myself, the Participant, as well as our personal representatives, assigns, heirs, and next of kin (hereinafter "Releasers") hereby:

ACKNOWLEDGE, agree and represent that Releasers understand the nature of the Activity and that the Participant is qualified, in good health, and in proper physical condition to participate in the Activity.

FULLY UNDERSTAND that Participant's participation in the Activity involves risks and damages of serious bodily injury, including permanent disability, paralysis, sickness, illness, and death ("Risks"). These Risks and dangers may be caused by the actions or inactions of myself, the Releasers, the Participant, the below-defined Releasees, others participating in the Activity, the organizers or sponsors of the Activity, or the owners of the location where the Activity takes place. These Risks include, but are not limited to, health, safety, welfare, social, and economic losses either known or not known to me or not readily foreseeable at this time. Releasers fully accept and assume all such risks and all responsibility for losses, costs, and damages that the Participant and Releasers may incur as a result of the Participant's participation in the Activity.

AGREE AND WARRANT that I and Participant will examine and inspect each Activity in which Participant may take part, and that if we observe any condition which we consider to be unacceptably hazardous or dangerous, we will notify the proper authority in charge of the Activity. Further, I will refuse to allow Participant take part in the Activity until the condition has been corrected to my satisfaction.

HEREBY RELEASE, discharge, and covenant not to sue JTAA, their Executive Board, any individual director, officer, administrator, agent, employee, or volunteer, and any other JTAA parent (hereinafter "Releasees"), from all liability, claims, demands, losses or damages on my account caused or allege to be caused in whole or in part by Releasees for: (a) any negligence; (b) any negligence related to the Activity; (c) any negligence regarding operations; (d) any negligence in allowing the Participant to participate in any Activity resulting on COVID-19 transmission; and (e) any negligence in failure to take, enforce, or ensure mitigation steps if the Activity is not cancelled resulting in COVID-19 transmission.

FURTHER AGREE that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement, any of the Releasers makes a claim against any of the Releasees, Releasers will defend, hold harmless, and indemnify each of the Releasees from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as a result of such claim.

I have read this Waiver, fully understand its terms, understand that have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this Waiver is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.
